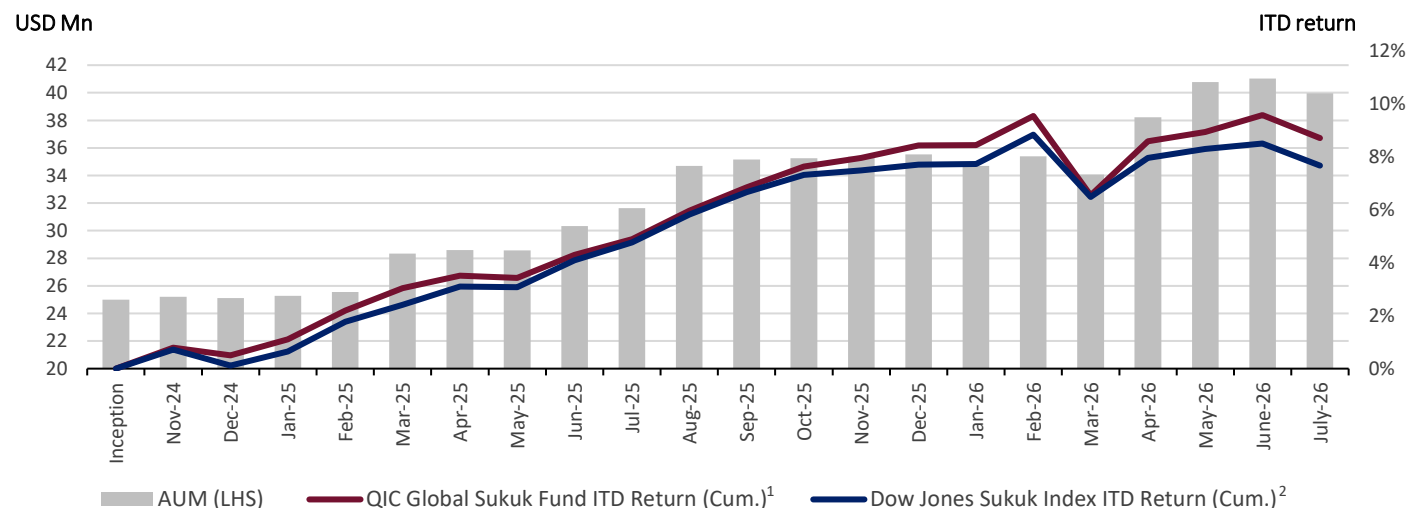
Investment Strategy

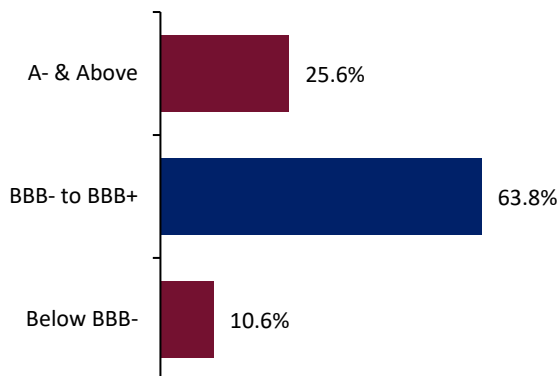

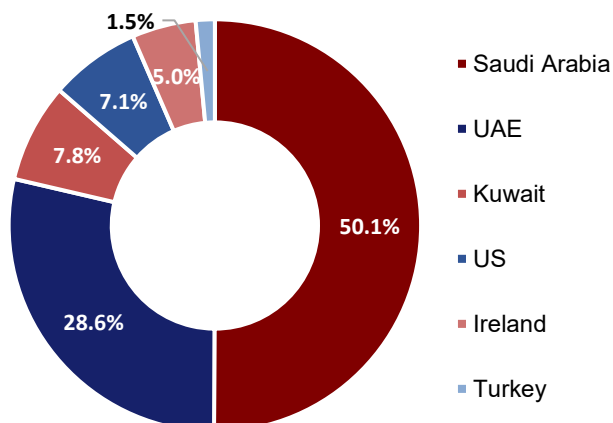

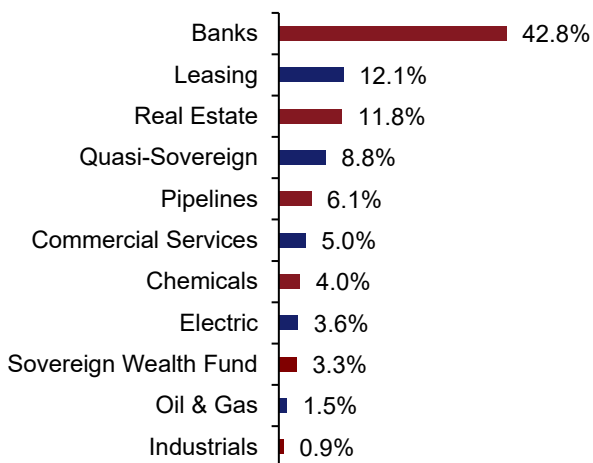
